GUCL does not require that applicants subscribe to the LSDAS.

- Two current**, original Letters of Recommendation in sealed envelopes
- Personal Statement**, two pages, double spaced, typed. Explain your motivation for attending law school and why this is a good time to begin law school.

When all documents have been submitted,  
a personal interview is scheduled for most applicants.

Prior law students, applicants educated outside the USA, or applicants seeking admissions as a Special Student should contact the law school for assistance.
